OFFICIAL RULES & PRIVACY POLICY

Must be 18 years of age or older to enter.**

Note: The date of the "Dream Wedding" cannot be changed. Entrants should not apply for the Giveaway unless they are available on this date. The goods and/or services awarded as part of the Giveaway have no cash value, are non-transferrable, non-assignable and may not be exchanged or refunded under any circumstances.

- 2. GIVEAWAY APPLICATION PERIOD:** The Dream Wedding Giveaway application period begins at 12:01 AM on November 18, 2019 (the "Giveaway Start Date"), and ends at midnight on December 27, 2019 (the "Giveaway End Date").

Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Any attempt by any participant to obtain more than one (1) entry per household by using multiple email addresses, identities, profiles, registrations and logins, or any other methods will void that participant’s entries and that participant may be disqualified. - b. Online Vote. Semi-Finalists will record a short video that will be posted online for public voting.
- c. The winner will be determined via an online vote via Facebook. The online vote will commence at 12:01 AM on January 10, 2020, and will end at 11:59 on January 17, 2020. The entry with the most votes at the expiration of the voting period will be declared the winner.
- d. The winner will be announced at the “Wedding Showcase” on January 19, 2020. Entrants do not need to be present to win the Giveaway.
